- With the addition of the electronic field destroy process, the customer can now fill out the request for credit. It will still be the responsibility of the representative to monitor what is being field destroyed. If the customer makes repeated errors, it may be requested that the representative take over the processing of the warranty items. Whether or not the customer fills out the form will be the responsibility of the representative, unless Zoeller requests the representative to process an individual customer.
- It is STRONGLY encouraged NOT to field destroy an entire system. This includes, but not limited to, 912
  Sewage systems, ProPak DC systems, DC Stand-Alone systems, Oil Guard systems. For example, the 266
  can be field destroyed for a 912 or the M53 can be field destroyed for a ProPak but there is no reason to
  destroy the entire system.
- Any exception from standard warranty for Zoeller products will require prior approval by a member of the Zoeller Pump Company Sales/Marketing management staff.
- Zoeller Pump Company will monitor each customer's return percentage and may occasionally require some units to be returned for quality assurance and auditing analysis in determining program changes.
