

SPECIFICATIONS

This alarm unit monitors liquid levels in lift pump chambers, sump pump basins, holding tanks, and other non-potable water applications (See Figure A). APak[™] Outdoor High Water Alarm features a green Power On LED, red alarm LEDs, an audible buzzer, one set of normally closed and normally open Auxiliary contacts, and a Silence/Reset/Test toggle switch. The APak[™] Outdoor High Water Alarm can be wired to a 120 V, 60 Hz, electrical power source. This product is rated as NEMA 4X. To maintain rating, use only equivalent rated conduits and install in accordance with applicable standards. Tighten enclosure screws once a year, (recommended torque of 0.45 Nm or 4 in-Ibs.) and perform any required maintenance to ensure protection. 15A household circuit breaker required.


ALARM UNIT INSTALLATION / WIRING

- 91104-0001. Drill openings on the bottom of the enclosure sufficient to accommodate the appropriate conduit adapter. Follow guidelines to ensure a water tight fit where applicable. Take care not to damage internal alarm components.
 91104-0002. The 20' corded switch and 6' power cord are already wired in place. These can be temporarily disassembled and removed for

- 2) Install unit in desired location using mounting flanges on enclosure.
- 3) Remove the 4 cover screws to access the terminal contacts and the auxiliary contacts.
- 4) Wire line and neutral to terminal contacts 1 & 2 and connect earth ground to the ground lug located on metal backplate (See Figure B).
- 5) Wire mechanical float switch to terminal contacts 3 & 4 (See Figure B).
- 6) Terminal contacts 5, 6, 7 are provided as an optional wiring junction point for the pump. 115/230V, 20A max.
- 7) Auxiliary contacts may be used to control other alarm circuits and are rated for 115V, 60Hz, 5A resistive load.






CONTROL/MECHANICAL SWITCH WIRING

Connect the two conductors from the high water float switch to input terminals as described above for the alarm unit (see Figure B). The alarm switch operates on low voltage to reduce shock hazards. The auxiliary contacts may be used to control another alarm circuit away from the location of the APak[™] Outdoor High Water Alarm system.

OPERATION AND TESTING

Check and test your installation by lifting the float manually. The alarm unit will indicate an alarm condition by buzzer chirping and lighting the red LEDs. The alarm may be silenced for 24 hours by briefly pressing the Silence toggle switch. Once silenced, the Red LEDs will remain on but the buzzer will not sound. Once the high-water condition is remedied, the alarm should be reset by holding the Silence toggle switch for 2 seconds. Hold the Silence toggle switch up to Test once per week to verify proper operation.

INSTALL MECHANICAL FLOAT SWITCH (011833 (15') or 011832 (20'))


- 1) Place cord into clamp and secure to discharge pipe as shown in clamp detail (see Figure C).
- NOTE: Do not install the cord under the hose clamp.
- 2) Tighten the hose clamp with a screwdriver.
- NŎTE: Do not over tighten; over-tightening may cause damage to the plastic clamp.
- 3) Make sure the float cable is not allowed to touch the excess hose clamp band during operation.
- 4) The float switch must be suspended 7" (17.8 cm) below desired activation level (see Figure D).
- 5) Be certain that installation of float allows for unobstructed range of motion.

IN A LIFT PUMP

Install float switch at a level above where the pump will energize. If a pump failure causes high-level condition, the APak[™] Outdoor High Water Alarm System will activate (see Figure A).


IN A HOLDING TANK

Suspend float switch into tank 7" (17.8 cm) below desired alarm level. APak™ Outdoor High Water Alarm System will activate if float ascends to alarm level (see Figure D).
